**Passenger Cancellation Policies:** No charges other than the non-refundable initial service fee/deposit are levied for individual passengers canceling up to 91 days prior to the commencement of Jet Vacations LLC services. **Full cancellation:** Failing to pay the contractual deposits (other than the initial non-refundable service fee / deposit) constitutes a cancellation. Payment shall then be received by Jet Vacations LLC within eight days as of the date of Jet Vacations LLC's written request. Should payment not be received within this time limit, the group stay shall be deemed to be canceled by the Customer.
